Cpr For Infants And Children

Developed in accordance American Heart Association standards on cardiopulmonary resuscitation (CPR), this program is designed to aid emergency professionals, teachers and others in maintaining a basic level of proficiency in emergency care for infants and children.

The most common causes of respiratory and cardiac arrest in children include motor vehicle injuries, drowning, foreign body airway obstruction, and poisoning. These tragic situations are almost exclusively preventable by the use of infant carseats, constant direct supervision, and keeping small objects that can be swallowed out of the reach of infants. However, in the event that an emergency does occur, knowing what to do is critical to saving the life of the young victim.

Respiratory specialists from UMDNJ's University Hospital identify the signs and symptoms of breathing crises and present guidelines for the initial treatment of them.

Differentiates between emphysemic, bronchitic and asthmatic distress and discuss ways to manage them including positioning the patient, inducing pursed lip breathing, and administering low flow oxygen therapy. Breathing Aids

Emergency Medical Technician trainer William Ward describes a variety of breathing apparatus and demonstrates their proper use. Shows the operation of suction units, oxygen tanks, nasal oxygen feeders, face masks, partial rebreathers, and venturi masks. Guidelines for the safe handling of high pressure oxygen tanks, and he explains how technicians can determine the total available oxygen flow available from a canister in use. 30 minutes, order 1-3730

Spinal Cord Injury: Rapid Extrication

Trainers demonstrate a variety of methods designed to protect the spine during initial treatment and transportation.

Suzanne Nawrock, an RN and EMTA, illustrates the use of Cervical and Thoraxic immobilization devices including the soft collar, hard collar, "KED", and long back board.

EMS education coordinator Chris Eldridge explains how to enact "rapid extrication concept" procedures. 28 minutes, order 1-3731

Bleeding and Control of Bleeding

Emergency medical response specialists present a variety of methods that will enable emergency responders to identify specific types of bleeding and to curb the rate of blood loss.

They demonstrate six external bleeding control practices: direct pressure, elevation, pressure points, splinting, mass garments, and tourniquets. The program also includes guidelines for managing internal bleeding, detecting and treating signs of shock, and differentiating among veins, arteries and capillaries. 17 minutes, order 1-3732

Diabetic Emergencies

Serious medical Sconditions as well as death can result if emergency response personel fail to recognize and treat a diabetic emergency.

Blunt Trauma

Trauma: Prehospital Assessment

Prompt and correct initial care of patients with multiple injuries is vital to their chances of survival.

This discussion includes descriptions of a rapid assessment to determine if the patient's life is threatened; a scene evaluation which includes safety and situation; and rapid examination skills, such as estimating blood pressure by presence of pulses, heart and respiratory rates, skin colour, and capillary refill.
